## Part A: Pupil premium strategy plan

## **Statement of intent**

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not. High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

## Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge	Detail of challenge
number 1. Language Skills	Assessments, observations, and discussions with pupils indicate underdeveloped oral language skills and vocabulary gaps among many disadvantaged pupils. These are evident from Reception through to KS2 and in general, are more prevalent among our disadvantaged pupils than their peers.
2. Reading	Assessments, observations, and discussions with pupils suggest disadvantaged pupils generally have greater difficulties with reading than their peers.
3. Maths Attainment	Internal and external assessments indicate that maths attainment among disadvantaged pupils is significantly below that of non- disadvantaged pupils.
4. Metacognition and self- regulation	Our assessments observations in class and knowledge of our children, have identified social, emotional and behavioural issues for many pupils, notably due to a lack of confidence, focus and resilience. Children are often lacking independence and have developed 'learned helplessness', which we must overcome. These are being addressed (primarily through our TPP training program), but these challenges particularly affect disadvantaged pupils, including their attainment in the long run.
5. Social and emotional well-being	Our assessments, observations and discussions with pupils and families have identified social and emotional issues for many pupils. These challenges particularly affect disadvantaged pupils. Teacher referrals for support remain relatively high. 10 pupils are currently on the SEN register with SEMH as their primary need. 21 children (14 of whom are disadvantaged) are currently receiving small group interventions for SEMH from our Pastoral Lead.
6. <b>Attendance</b>	Our attendance data indicates that attendance among disadvantaged pupils is lower than for non-disadvantaged pupils. This academic year 22% (13/59) of disadvantaged pupils have been 'persistently absent'. Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.

## **Intended outcomes**

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

# Part B: Review of outcomes in the previous academic year

## **Outcomes for disadvantaged pupils**

We have analysed the performance of our school's disadvantaged pupils for 2023 - 2024, drawing on national assessment data and our own internal summative and formative assessments.

To help us gauge the performance of our disadvantaged pupils we compared their results to those for disadvantaged and non-disadvantaged pupils at national and to results achieved by our non-disadvantaged pupils.

The data was as follows:
